### Acknowledgment & Assumption of Risk, Release, and Waiver of Liability Regarding Sports Participation (Parent/Guardian & Minor Student)

#### **Student Name:**

IN CONSIDERATION OF the above-named student ("Student") of Norwich Free Academy ("NFA"), a school operated under the jurisdiction of the Norwich Free Academy Board of Trustees (the "Board"), being allowed to participate in any way in NFA-sponsored intramural or interscholastic sports and related events and activities occurring both within and outside the State of Connecticut ("Sports Activities"), I, the undersigned and Student's parent or legal guardian, by signing below hereby acknowledge, understand, and agree to the following:

- 1. I acknowledge that Student's participation in the Sports Activities is voluntary, that Student is not required to participate in the Sports Activities, and that participation in the Sports Activities is, not a condition of Student's attendance at NFA, award of course credit, progress towards graduation, or receipt of any award or recognition.
- 2. I understand that participation in the Sports Activities involves risks not present during Student's regular attendance at NFA including, without limitation, risks involved in traveling to, from, and within locations outside the boundaries of NFA, and I recognize that Student may be subjected to potential risks, illnesses, injuries, disability, and even death. I understand these risks and assume them knowingly and willingly. I further agree that Student is to abide by all local laws or rules of the locations Student travels to while participating in the Sports Activities.
- 3. I further understand that at present, a global pandemic has been declared and is ongoing regarding the spread of the novel coronavirus 2019 and the disease it causes ("COVID-19") and the risk of serious illness, injury, or death resulting from contracting COVID-19. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. Although NFA and the Board have implemented certain preventative measures consistent with applicable rules, regulations, federal and state orders and guidance, and guidance from public health officials related to COVID-19 which may reduce this risk of spreading and contracting COVID-19, the risk of contracting COVID-19 and of serious illness, injury, and death resulting therefrom cannot be eliminated. NFA and the Board cannot ensure that students participating in the Sports Activities and/or their families or others in a student's household will not become infected with COVID-19, or with any other communicable disease such as MRSA or influenza. Participation in the Sports Activities includes possible exposure to and illness, injury, or death from infectious diseases including COVID-19. Moreover, NFA and the Board cannot protect against exposure to or infection by COVID-19 that occurs due to the actions, omissions, and/or negligence of students or others, including NFA staff members.
- 4. I understand the risks related to COVID-19 associated with participating in the Sports Activities. I further understand that there are cardiovascular and other health and safety risks associated with returning to athletic activities after COVID-19 infection. I also acknowledge that the health and safety risks posed by COVID-19 cannot be completely eliminated, despite the implementation of reasonable and age-appropriate precautions and protocols. I further understand that there may be risks to Student associated with adhering to certain mitigation strategies recommended and/or required by the Department of Public Health and/or the Centers for Disease Control and Prevention and required by NFA and the Board, such as wearing a face-covering or mask that completely covers the nose and mouth, including during active play. Finally, given the unknown nature of COVID-19, I understand that it is not possible to list each and every specific risk associated with COVID-19 and that neither NFA, the Board, nor public health officials can guarantee that any student participating in the Sports Activities or other in-person activities will not come into contact with someone infected by COVID-19 and/or contract such illness.
- 5. By opting to allow Student to participate in the Sports Activities, I agree that I and Student will abide by any health and safety protocols that NFA and the Board may require, such as requiring students to wear face-

coverings or masks that completely cover the nose and mouth (including during active play) and adhering to any guarantine periods required by NFA and the Board.

- 6. In recognition of the agreements and understandings set forth above, I agree, on behalf of myself, Student, and on behalf of both my and Student's family, heirs, assigns, and personal representative(s), to ASSUME ALL THE RISKS AND RESPONSIBILITIES, both known and unknown, inherent or otherwise, surrounding Student's participation in the Sports Activities, including those arising from the negligence of others, and assume full responsibility for Student's participation in the Sports Activities. Further, to the maximum extent permitted by law, I RELEASE, HOLD HARMLESS, AND AGREE TO INDEMNIFY NFA and the Board, and their officers, trustees, staff, representatives, employees, volunteers, and agents (the "Released Parties"), from and against any present or future claims, losses, liabilities, costs, and expenses for injury, illness, disability, or death to person or damage to property or for any other damage which I or Student may suffer, or for which I or Student may be liable to any other person or entity, related to Student's involvement or participation in the Sports Activities (including periods in transit to or from the Sports Activities), resulting from any cause, including but not limited to negligence on my part or on Student's part. I further WAIVE THE RIGHT to initiate and/or pursue in any manner any and all lawsuits and any other claims in any forum against the Released Parties for any injury or harm connected to Student's participation in the Sports Activities. These agreements of assumption of risks and waiver do NOT apply if (1) the liability, damage, loss, or injury is CAUSED SOLELY BY THE NEGLIGENCE of the Released Parties and do not include the negligence or any other act or omission by any other person or entity (such as Student, the Parents, other student-athletes, other third parties or independent vendors/contractors); or (2) the liability, damage, loss, or injury is CAUSED BY THE RECKLESS, WANTON, or INTENTIONAL MISCONDUCT of a Released Party.
- 7. I agree that Student is required to abide by NFA's policies, regulations, and procedures governing or related to participation in the Sports Activities. I assert that I have explained to Student the risks of the Sports Activities, Student's responsibilities for adhering to the rules and regulations, and that Student understands this agreement.

I certify that I am age 18 or older. I have carefully read and freely sign this Acknowledgment & Assumption of Risk, Release, and Waiver of Liability. I fully understand and agree that this Acknowledgment & Assumption of Risk, Release, and Waiver of Liability is a legally binding agreement, that I on behalf of myself and Student have given up substantial rights by signing it, that no oral or written statements or representations can or will alter the contents of this document, and that I and Student sign it freely and voluntarily without any inducement or undue influence. I agree that this agreement shall be governed by the laws of the State of Connecticut (excluding its conflict of laws principles), which shall be the forum for any lawsuits filed under or incident to this agreement or the Sports Activities. I further agree that this agreement is intended to be as broad and inclusive as is permissible by the laws of the State of Connecticut and that if any portion of this agreement is held to be invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect.
